### **Penalty Kick**

- The kick is taken from the penalty mark.
- All players, except the player taking the kick and the opposing goalkeeper, shall be within the field of play but outside the penalty area, at least 10 yards from the penalty mark and behind it.
- The goalkeeper remains on his/her line, between the goalposts, but may move along the goal line before the ball has been kicked.
- The player taking the kick must kick the ball forward.
- **He/She shall not play the ball a second time until it has been touched or played by another player.**
- The ball is in play when it is kicked and moves

forward.

- A goal may be scored directly from a penalty kick.

### **For any infringement...**

- *By the defending team:* the kick shall be retaken if a goal has not resulted.
- *By the attacking team other than the kicker:* if a goal is scored it shall be disallowed and the kick retaken.
- *By the player taking the kick committed after the ball is in play:* a player of the opposing team shall take a free kick from the spot where the infringement occurred, depending on the nature of the infringement.
